Minutes of the 2023 Annual Meeting of the Georgia Entomological Society

Executive Committee Meeting Minutes April 19, 2023. Unicoi State Park, Helen, GA

Attending: David Shapiro-Ilan (President-Elect), Kris Braman (Historian), Brett Blaauw (President-Elect), Stan Diffie (Secretary-Treasurer), Nancy Hinkle (Past-President), Jason Schmidt (Local Arrangements), Dan Suiter (Nominations) and David Buntin (JES). Wayne Gardner (JES) attended via phone.

Nancy Hinkle made a motion to open the meeting and Kris Braman seconded the motion. David Buntin was introduced as the Associate Editor of the JES and would be available during the meeting for questions. It was announced that Scott Croxton is the current industry representative but would not be able to attend the 2023 meeting due to a medical issue. The regular meeting is set to run until 1:00 and check-out is at 11:00 which may pose a time crunch for members.

Program Committee (Brett Blaauw) –The program is full and could be a record with 77 papers and talks scheduled. This has pushed the regular completion time from 12:00 to 1:00 pm on Friday. Speakers are encouraged to load their presentations each morning from 7:00 to 8:00 am. In compiling the program, Google Docs was used. This worked well but some formatting issues arose. Brett encouraged proofreading by the members submitting papers and posters.

Local Arrangements Report (Jason Schmidt) – The taco lunch buffet line will be set up outside the meeting room for members at 12:00 on Thursday. They are encouraged to return to the meeting room for the photo salon. The poster session and silent auction will close at 6:00 Thursday and members will be encouraged to move downstairs for awards and supper. An open drink station has been arranged with coffee, soft drinks, and water. Cookies will be provided during the three breaks. A BBQ will be held Thursday evening at which time student awards will be presented. A bonfire will be available outdoors after dinner for members to mingle and socialize.

Scholarship Report (Nancy Hinkle) – Nancy reported five people applied for the Ph. D scholarship and five people applied for the M.S. scholarship. This was a big improvement over previous years such as 2022 where only one Ph D application was received. The applications were all good and the winners will be announced at the student awards ceremony Thursday evening.

Nominations Committee Report (Dan Suiter) – The committee asked Ash Sial to run for President-Elect. No one else volunteered to run, so Ash will run unopposed. It will be a voice vote and nominations will be taken from the floor.

Membership Committee (Stan Diffie)—Stan distributed a graph of meeting attendees since 2014 showing a noticeable increase in attendance at the past four meetings. He attributed this to an increase

in student attendance. He also distributed a table comparing the membership totals in 2017 vs 2023. Again, an increase in student numbers was the only difference.

Journal of Entomological Science Annual Report (Wayne Gardner)—Wayne joined the conversation via phone to give his report. Volumes 20-58 are archived online and are available to anyone through Open Access. The biggest thing Wayne is working on is the ability to put articles online immediately. A \$300 setup fee will be required, and each article will be charged \$19.00. This fee could be included in the author's page charges or the author could be given the option to participate. Allen Press was purchased by CTJ Group and Sheridan Kansas is the new name for Allen Press. Wayne asked about going totally online. One point to be made known is that libraries still receive paper copies. Hard copies constitute about 30% of the journal's annual expenses.

Wayne asked for an ad hoc committee to be formed to search for a replacement editor for when he decides to retire. The committee should also look for a new Business Manager, too. He pointed out that traditionally, the journal's impact factor has been around 0.3 but has moved up to around 0.67. He encouraged GES members to submit papers for publication. A brief discussion on publishing meeting symposia took place.

The Executive Committee agreed to recommend adding the additional charge to all authors and having all articles 'Firstsight'. The Executive Committee suggested keeping hard copies for now. Students will not receive hard copies because they move so much, and the returned copies are a burden and an unnecessary cost.

Financial Report (Stan Diffie) – The current financial report was presented (attached) to the committee. The finances of the Society have remained relatively stable over the past few years. We have received excellent financial support from the corporate sponsors. Stan thanked Dan Suiter and Phillip Roberts for their help in securing funding. There will probably be a net loss this year due to the added expenses of the Thursday evening meal, but it should not be a big concern over time.

Historian report (Kris Braman) – Kris wants to encourage everyone to submit old programs, pictures, etc either as hard copies or electronic copies for the Society archives. David Buntin said he thought a whole series of the journal was present on the Griffin campus. Kris said another 'History of the GES' needed to be written.

Site Selection (Jason Schmidt) – Jason was slotted to be the site selection chair for 2024 so when asked about next year, he suggested going back to the beach. It appears the 'mountains to the beach' approach is working well for the membership currently. Stan reminded everyone that Scott Croxton suggested a joint meeting with the Florida Ent Soc, but several members express concern over the idea. Nancy reminded the site selection committee to remember Lund Week—the third week in April—when deciding on a time for the next meeting. No information was available for a time or place since no site selection chair was available.

David Buntin moved to adjourn.

Final Business Meeting Minutes April 21, 2023. Unicoi State Park, Helen, GA

David Shapiro-Ilan presided over the Final Business Meeting of the 85th annual GES meeting. The meeting was not officially opened, but David made some thank you remarks at the beginning.

The moderator did not call for the reading of the minutes of the last meeting.

An agenda was not distributed nor followed throughout the meeting.

David asked for the fishing report from Will Hudson. It was brought to David's attention that the results of the Snapp Award were being tabulated. He then called on Shimat Joseph for the results.

Snapp Award (Shimat Joseph) – The Snapp Award, for best presentation by a regular member, was presented to Kyle Slusher for his presentation of "EPNs and Weevils: Use of entomopathogenic nematodes to manage weevils in pecan".

Fishing Tournament (Will Hudson) – Guidelines were again revised to ensure a moving target for the participants. The team of Abney and Roberts submitted the largest fish. However, the length had to be divided by two since there was not a clear ruling as to who caught the fish. Therefore, George Braman's entry won with a fish of 12 ¾ inches.

David suggested closing the meeting at this point since it was 1:00 but asked if any of the committee chairs wanted to give their report.

Audit Report (Phillip Roberts) – Phillip spoke up and reported that the committee had reviewed the financial reports and found everything to be in order. The report is attached.

Ed Mondor, past chair of the Operating Guideline Committee, asked about voting on the revised Operating Guidelines he had worked on a couple of years ago. A vote was not taken, but it was suggested the membership be able to review the revised document before the next meeting.

Silent Auction (Linda Smyth) – Linda thanked everyone for another successful auction. She reported over \$600 had been raised from 90 viewing stations.

Resolutions (Shimat Joseph) – Nancy Hinkle moved to dispose with the reading of the resolutions but to have them included in the minutes on the website (attached).

Site Selection – David asked Jason for the report for next year's meeting. Stan pointed out that a site selection chair had not been appointed. Jason stepped in and said he would serve again next year. However, he had nothing to present to the membership except for the idea that we would return to Jekyll Island. Ed Mondor incorrectly stated that at least two options had to be presented. Nancy Hinkle suggested Athens. A voice vote was taken, and Jekyll was selected. Nancy reminded Jason of Lund Week the third week of April.

Secretary/Treasurer Report (Stan Diffie) – The financial report covering activity from 2018 through 2022 was distributed to attendees. (See below).

Necrology Report — It is not known as to whether David asked anyone to compile a report or not.

Journal of Entomological Science (David Buntin) – No report was given. The report compiled by Wayne Gardner is attached.

Nominations Committee (Dan Suiter) – Ash Sial agreed to serve as President-Elect.

Insect Survey (Mark Abney) – No report was given. See current report on the GES website.

Fun Run (Jason Schmidt) – No report was given.

Award Winners – There was no call for the reading of the award winners. (A list of award winners has been compiled and can be found below).

Conclusion (David Shapiro-Ilan) – David passed the gavel to Brett Blaauw.


Brett Blaauw presented David Shapiro-llan a plaque for his service as GES President.

Report of the GES Audit Committee

Stan Diffie provided monthly bank statements, PayPal statements, CD statements and receipts for review of financial activities of GES from January 1, 2022, through December 31, 2022.

I completed reviewing these materials on April 13, 2023.

In comparison of account information to the financial report, the beginning and ending balances for the Checking, PayPal and CD are accurately reflected in the report. These materials appear consistent with proper financial management of the Society.

All significant disbursements of funds were accompanied by appropriate receipts. All movement of funds from PayPal are reflected in deposits into the GES checking account.

More than \$2,000 was paid to the Journal. Mr. Diffie explained that these are page charge funds collected through PayPal on behalf of the Journal and are simply passed through the GES account as a service to the Journal.

2022 ANNUAL REPORT

Volume 57 of the *Journal of Entomological Science* was published online and in print in 4 quarterly issues with a total of 627 pages, 41 scientific articles, and 11 scientific notes. For the 52 manuscripts published in the volume, the average time from receipt of the manuscript to action taken on acceptance was 37 days (See Table 1 for summary data by volume from 2006 through 2022). Cover photos for each of the issues were provided by Brett Blaauw of the University of Georgia (no. 1), Lisa Ames of the University of Georgia (no. 2), Alex Orfinger of the University of Florida (no. 3), and Becky Griffin of the University of Georgia (no. 4).

During 2022, 78 manuscripts were submitted for consideration for publication in the *Journal*. The acceptance rate for those submissions was 58%. Of those submitted, only 12 (15%) were submitted by GES members, 2 (3%) were submitted by U.S.-based non-GES member authors, and 64 (82%) were submitted by authors affiliated with non-U.S. institutions [China (20), India (17), Mexico (6), Thailand (5), and 16 from 11 other countries]. A summary by year of total submissions, acceptance rates, and the account balances and net incomes for years 2006 through 2022 is shown in Table 2.

Susan Thornhill, Business Manager, reported a balance of \$37,628.67 in the *Journal* checking account at Regions Bank (Griffin, GA) as of 30 March 2023. Deposits, disbursements, and balances for the year are listed in Table 3, while Table 4 provides a breakdown of the publisher fees and charges.

The CJL Group, headquartered in Brainerd, MN, acquired the assets of Allen Press (Manhattan, KS) in 2022. This acquisition unites Allen Press with the Sheridan family of print companies and KnowledgeWorks Global Ltd. (KLG) which offers content services such as editorial, peer review, and online hosting for journals. The Allen Press facility will now become Sheridan Kansas, one of ten Sheridan printing facilities in the United States. Our journal, however, will be printed and mailed at the Sheridan Pennsylvania facility to take advantage of their digital presses. KLG will be managing those services of PeerTrack, editing, publishing, and online hosting. To date, the changes associated with this acquisition have been seamless from our perspective.

The online version of the Journal of Entomological Science is now open access for all those visiting our site at gaentsoc.org as well as through the link https://bioone.org/journals/journal-of-entomological-science/issues on the BioOne site. Discussions are in progress with our parent publishing company (KGL) regarding implementing the FirstCite Advance Online Publication. This would provide for papers to be published on the *Journal* online site following acceptance and preparation for production.
